**Wisconsin Environmental Education Board Announces  
Enhanced Forestry Education Grant Program**

The Wisconsin Environmental Education Board (WEEB), located at the University of Wisconsin-Stevens Point, is seeking proposals for the 2002-2003 grant cycle.

This year the Board anticipates awarding \$390,000 from the forestry account of the Conservation Fund for forestry education based projects. This is an increase of \$200,000 from last year.

The WEEB also will award \$180,000 for energy related projects. The funds for this segment of the grant program are derived from WI Focus on Energy Funds. An estimated \$30,000 will be distributed for general environmental education projects. These funds are the result of environmental fines levied and collected and individual donations.

Public and nonpublic educational institutions, all units of government, and corporations (nonprofit, nonstock) are eligible for WEEB grants. Requests may be for a mini-grant (\$1,000 or less and restricted to novice grant writers), small grant (up to \$5,000) or large grant (\$5,001 to \$20,000). Submitted proposals will be evaluated in three categories: forestry education, energy education, and general environmental education. Projects must be designed for Wisconsin residents and assist learners in achieving the goals of environmental education (EE).

Initiated in 1990, the WEEB's mission is to "provide leadership in the development of learning opportunities that empower Wisconsin citizens with the knowledge and skills needed to make wise environmental decisions and take responsible actions in their personal lives, work places, and communities."

Proposals must meet one or more of the following priorities to be considered for funding:

- A. Assist the WEEB in meeting **statewide** initiatives, including:
  1. **statewide** implementation of environmental education program approval guidelines for PI 34 Standards for teacher licensing and certification
  2. **statewide** assessment of student environmental literacy
  3. **statewide** environmental education leadership development or enhancement programs.
- B. Promote broad community environmental education through the development and implementation of community environmental education projects. Projects should increase:
  1. the number and/or diversity of individuals and/or organizations involved in environmental education
  2. community knowledge of specific environmental issues or problems
  3. community participation in the resolution of environmental problems
- C. Make use of existing resources and successful projects. This does *not* include support of the ongoing operations of a program. Existing resources and successful projects are defined as:
  1. interdisciplinary environmental curricula
  2. environmental education training for staff or group leaders
  3. environmental education programs developed for use on outdoor sites
  4. successful programs or WEEB projects developed by the applicant or another entity

D. Create new environmental education resources or programs.

E. Promote the implementation of Wisconsin's Environmental Education Academic Standards.
