

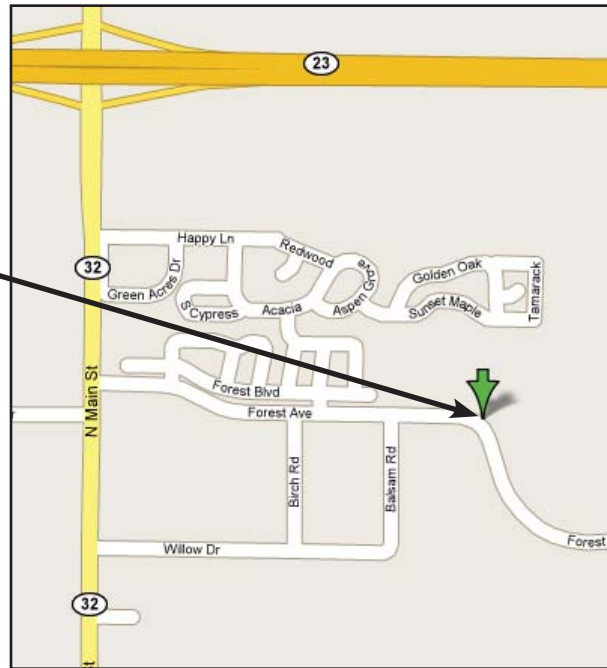
Location
