

# Application for Exception to Housing Requirement

UW System Board of Regents' Residency Requirement states - Those freshman and sophomore students who are not veterans, married or living with parents or guardian, shall be required to live in a university-operated residence hall when such accommodation is available. (Policy 173, May 5, 1972)

UW-Stevens Point follows the UW Board of Regents' Residency Requirement. UWSP Housing requires all students who are two years or less out of high school to live on campus. UWSP Housing has the obligation to enforce both the Board of Regents' Policy and the terms of the Housing and Dining Contract. Students enrolled at UWSP, beginning with the fall semester, must meet one or more exception criteria by the first day of fall semester classes to be exempt from living on campus that academic year.

- I have my child(ren) living with me (must provide a copy of the birth certificate(s) and verification by a third party that the child is living with you with this form).
- I am enrolled only in extension or online degree programs found at <https://www.uwsp.edu/online/>. Will be verified by UWSP Housing office.
