### MISSION:

The Office of the Dean of Students strives to maximize each student's learning experience by creating a culture of care, fostering personal responsibility, and encouraging involvement as local and global citizens. To our students: *You Matter.*

### SERVICES AND PROGRAMS

- Support students with concerns or experiencing some form of crisis.
- Direct the University student conduct process and associated training.
- Coordinate University compliance to Jeanne Clery Act, VAWA, Campus SaVE Act, Title IX, and the UWS Annual Sexual Assault Report process.
- Support University operations through service on divisional, University, and UWS committees.
- Oversee AODA and Interpersonal Violence primary and secondary prevention efforts.

### DEPARTMENTAL ACHIEVEMENTS:

- Managed expansion of services and service requests to include students of concern, the student conduct process, and Title IX investigations while understaffed.
- Adjudicated approximately 100 cases within DOS office and supported adjudication of more than 675 cases by Residential Living and SIEO.
- Expanded expertise in student care and University compliance areas by attending: Motivational Interviewing training, Level 3 Civil Rights Investigator training, NaBITA Campus Threat Management Institute, Higher Education Case Manager Association national roundtable, and state level trainings.
- Integrated sexual assault prevention online requirement and interpersonal violence prevention presentation into Welcome Week as well as partnered with Portage County CAP Services Family Crisis Center Sexual Assault and the City of Stevens Point on Domestic Assault and Sexual Assault Awareness Month programming.
- Served on Students of Concern, the Behavioral Intervention Team, Tuition Appeals Committee, A-Team, Suspension/Readmission Committee, University Retention Management Team, University Affairs Committee of Faculty Senate, Diversity Council, Homecoming and Welcome Week Committees, AODA Prevention Partnership and Management Team, and UWS Clery Compliance Oversight Group.
- Working with the UWSP Student Government Association, *increased* usage of Student Legal Services by 21.7% and *increased* the number of applications for SGA Scholarships by 39.1%.
- Formalized and hired for positions of Assistant Dean of Students-Case Management and Program Director for the Center for Prevention (AODA/IPV Prevention).

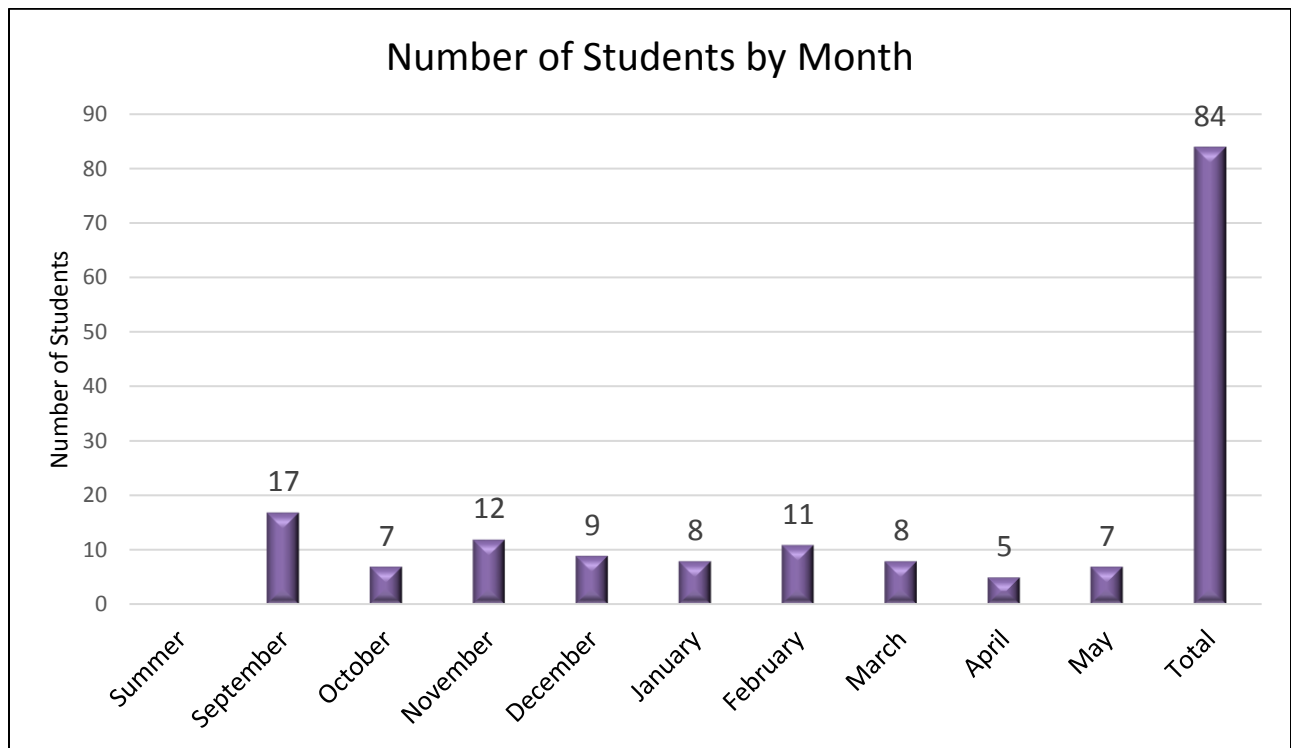
### INCLUSIVE EXCELLENCE

- Partnership with WRC, PAVE, and community to address issues of sexual violence

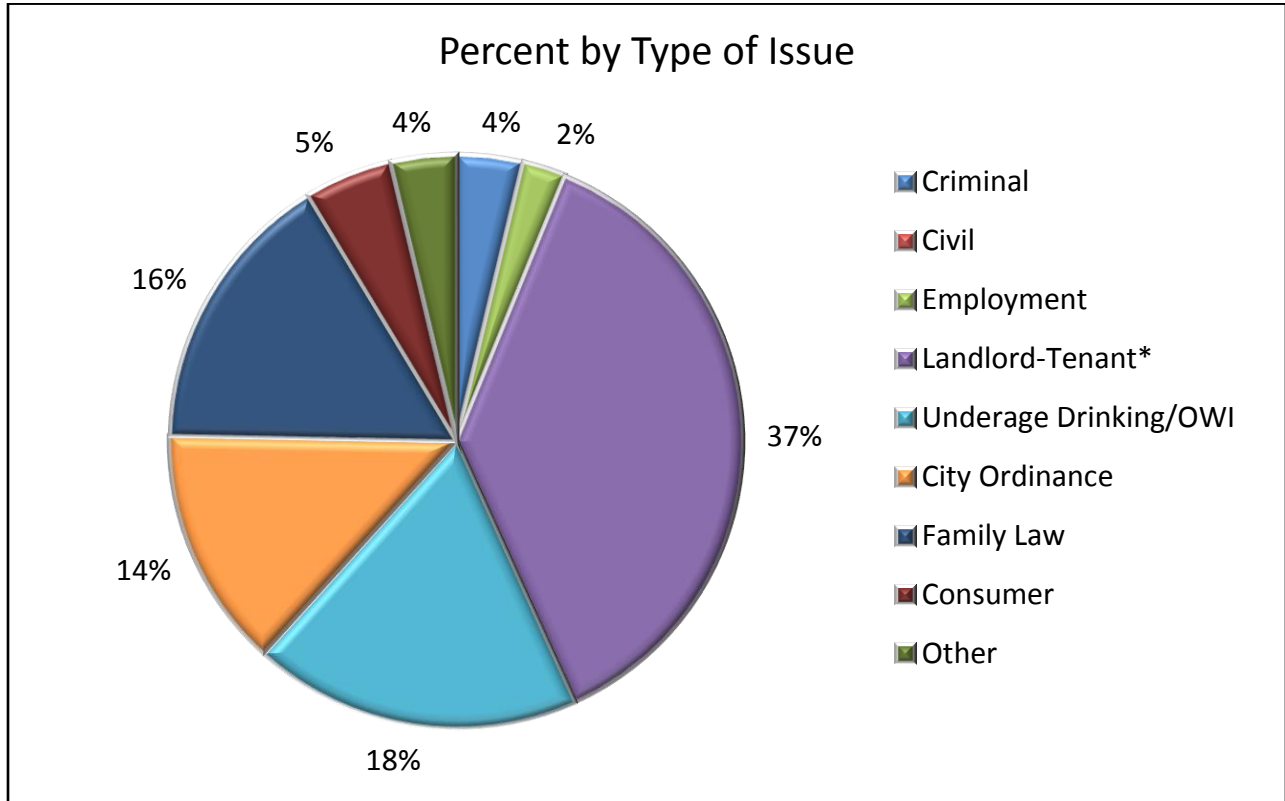
## GOALS FOR 2016-2017

  - Increase visibility of DOS across campus
    - Hold office hours in DUC, outreach to frontline staff, and faculty
  - Launch online training all Campus Security Authorities (CSAs)
  - "Humanize" the student conduct process
  - Implement the UW-Stevens Point Bystander Intervention Program for campus
  - Create bias/hate incident response process/team
  - Assist with parent outreach efforts
  - Provide educational opportunities for faculty and staff regarding Title IX, VAWA, SaVE Act, Clery, trends in student mental health, academic misconduct, classroom behavior management, and violence on college campuses
- Create and measure learning goals/outcomes for student interaction with DOS office
- Create strategic plans to address AODA and IPV efforts

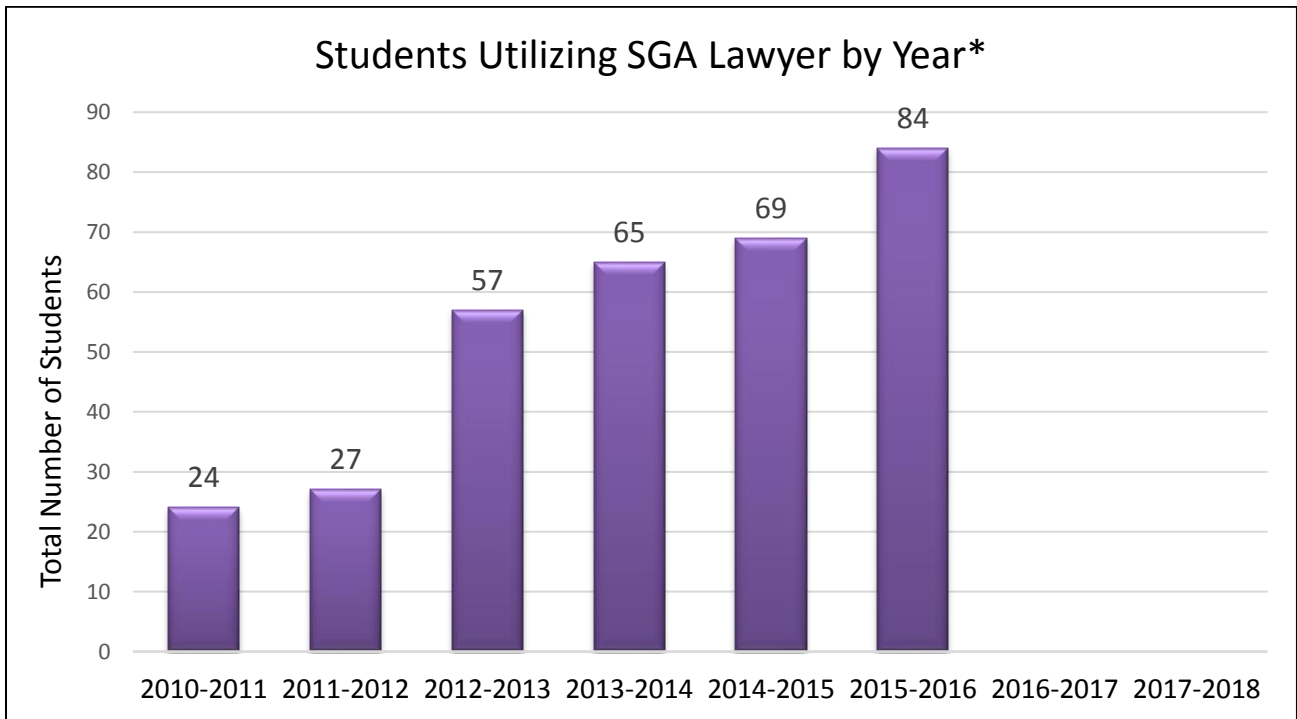
## 2015-2016 Student Legal Services (funded by SGA)



**2015-2016 Student Legal Services (funded by SGA)**

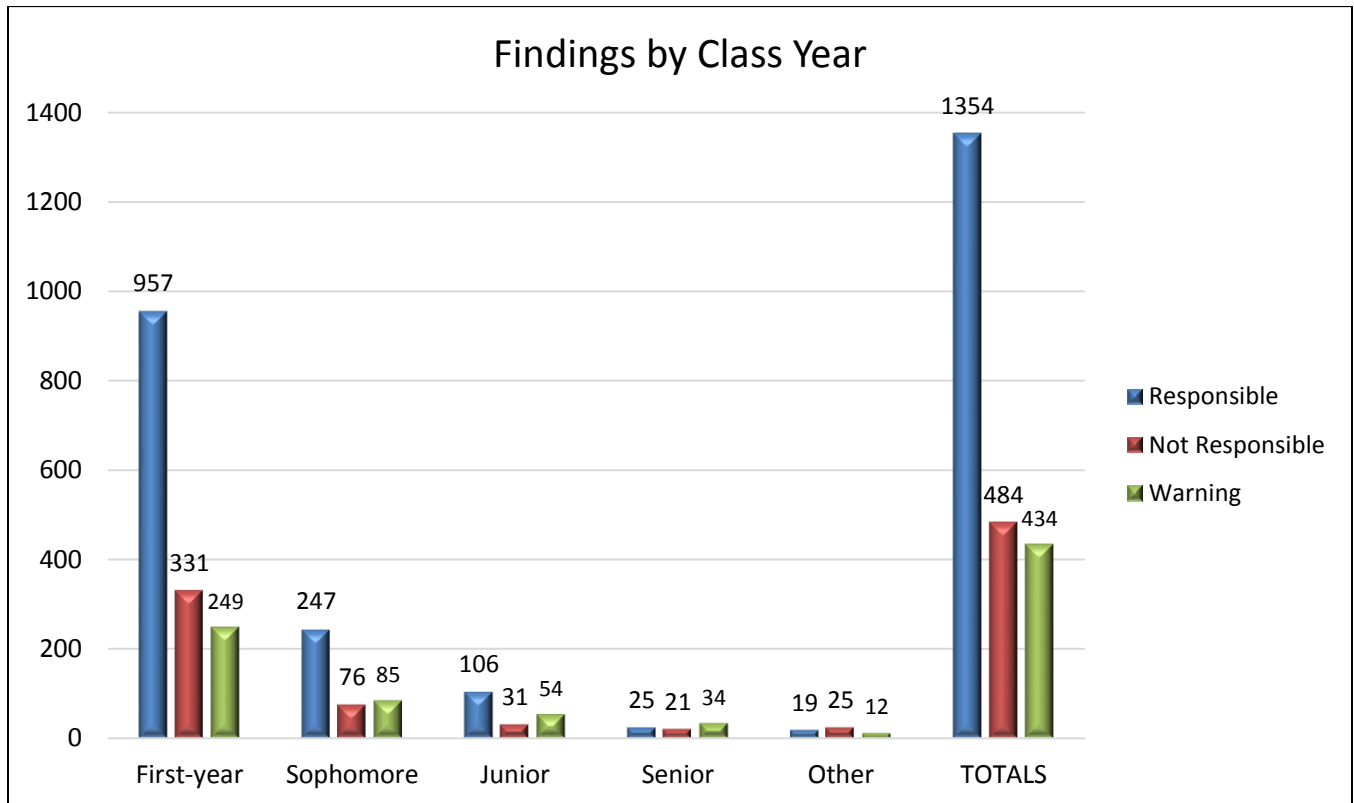


\* Landlord-tenant issues typically involved 2-4 students so overall student numbers lower than actual usage of the SGA funded Student Legal Services



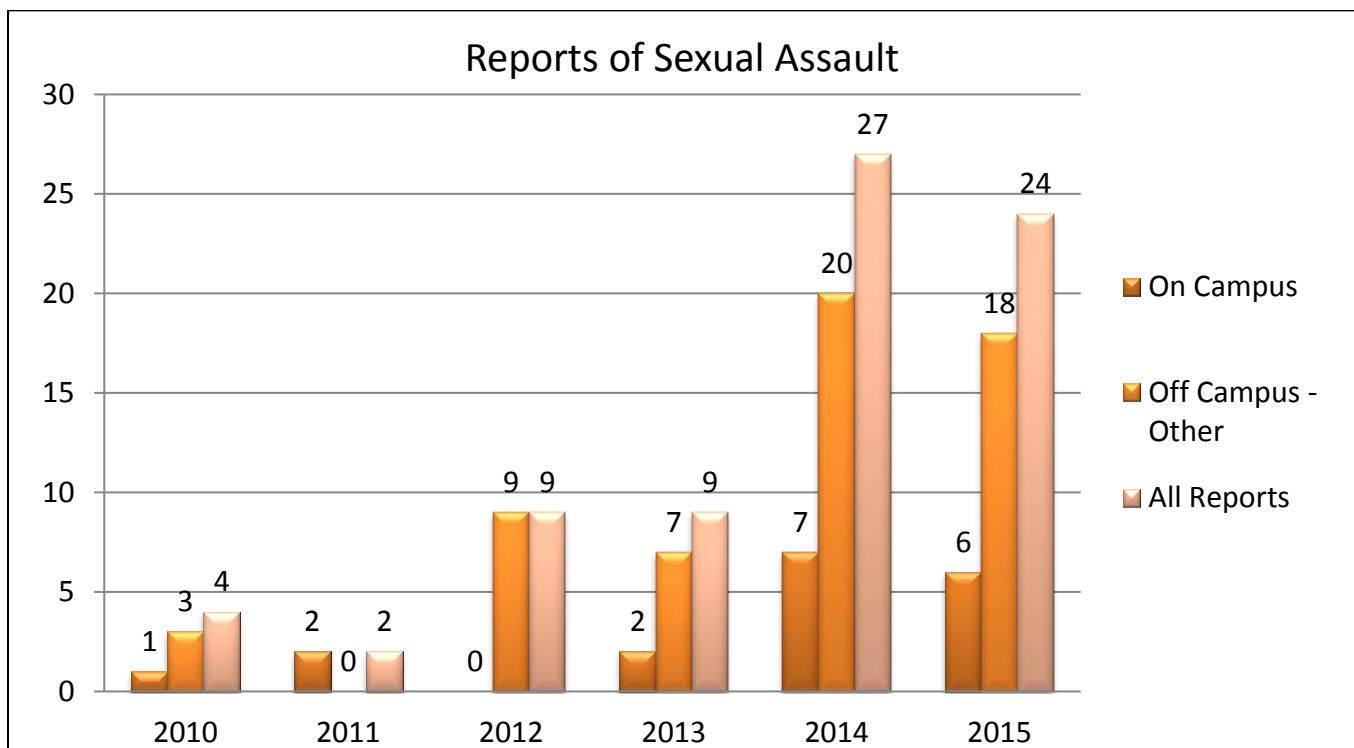

## 2015-2016 Conduct Summary

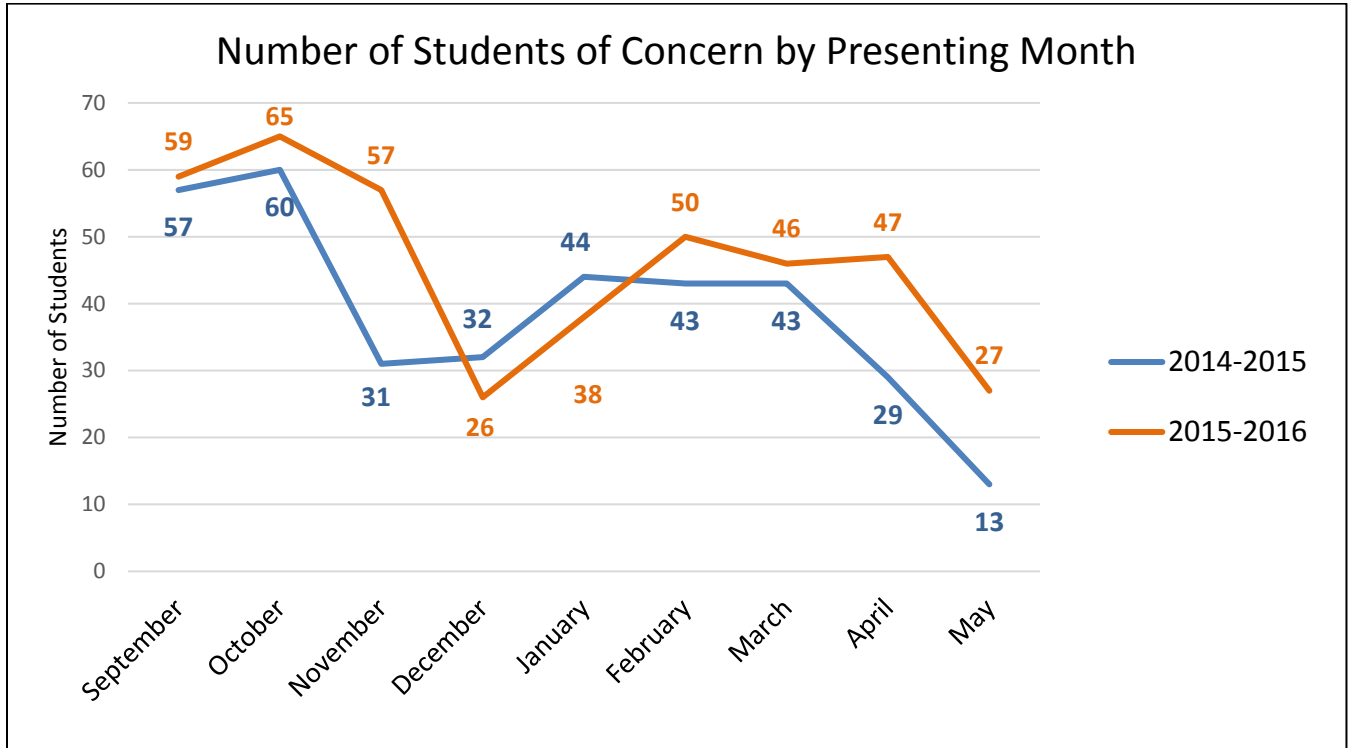

## Reports of Sexual Assault/Investigations (Calendar Years)

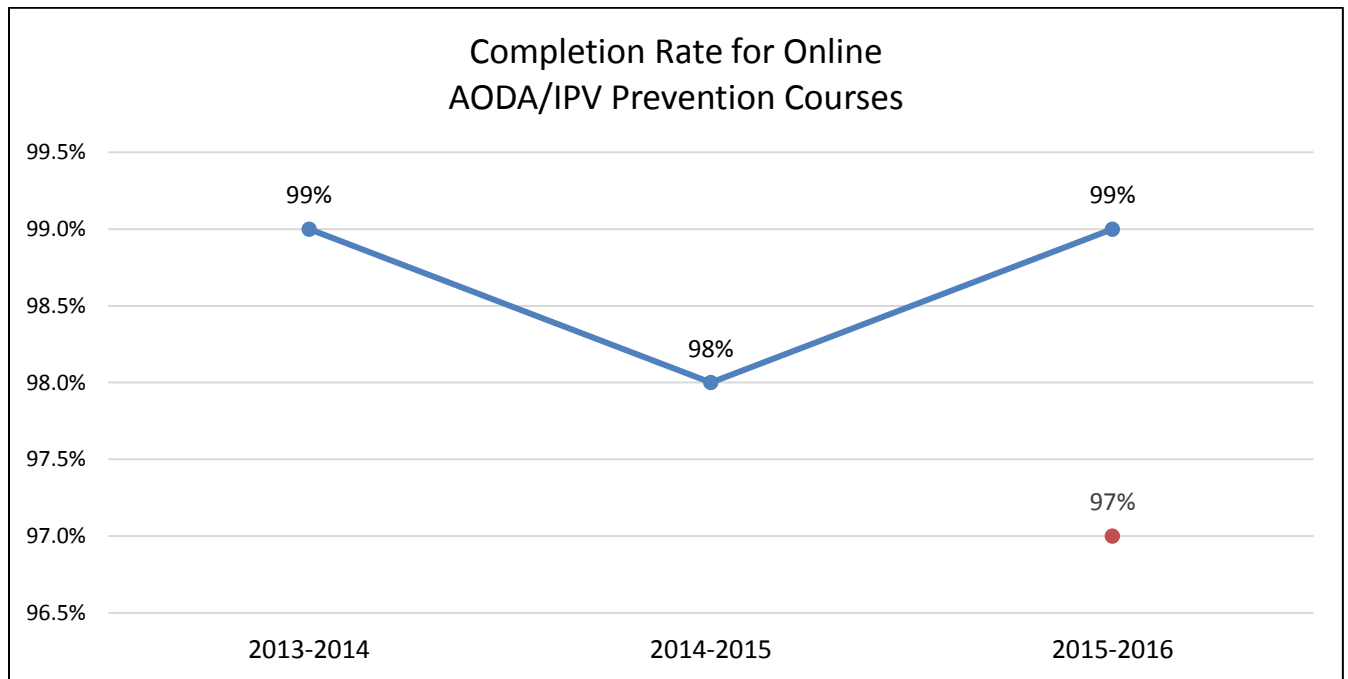


**Students of Concern**
