5. COURSEWORK DESCRIPTIONS & COMMENTARY

5.1. *Exams*

4 Exams: <u>Make-up exams</u> <u>are not permitted</u> except for extraordinary circumstances beyond your control and require <u>advance</u> approval. Documentation such as a copy of an obituary or doctor's note for verification purposes may be required. In the extremely rare situation where a makeup exam is approved, it must be taken before the exams are handed back to the class. In the instance that this is not possible, the available points will be added to the final exam. There will be four unit exams during the semester. The exams will consist primarily of multiple choice questions and short problems. Short problems will be similar to those completed in class or for homework. *For in person tests, students will not be permitted to leave the classroom while the test is being administered.
