5. COURSEWORK DESCRIPTIONS & COMMENTARY

5.1. *Exams*

Exams: Make-up exams are not permitted except for extraordinary circumstances beyond your control and require advance approval. Documentation such as a copy of an obituary or doctor's note for verification purposes may be required. In the extremely rare situation where a makeup exam is approved, it must be taken before the exams are handed back to the class. In the instance that this is not possible, the available points will be added to the final exam. There will be four unit exams during the semester. The exams will consist primarily of multiple choice questions and short problems. Short problems will be similar to those completed in class or for homework. *For in person tests, students will not be permitted to leave the classroom while the test is being administered.

For this course, you must attend **two** official Pro Events. One event must be before the mid-semester cut-off of Oct. 27, 2023; a second event must be before the end-of-semester cut-off (Dec. 15, 2023). If you go to extra events before the mid-semester cut-off, those credits will carry over into the second half of the semester. Attendance at each event will count for 30 points/8% towards your final grade.

Only students registered for 100% online or branch-campus classes have access to Pro Events recordings. The number of videos available will be pro-rated based on the number of such courses in which you are enrolled. Video events must be completed one week before the general Pro Events cut-offs. For Fall 2023, the video deadlines are Oct. 20 for the first half-semester and Dec. 8 for the second half-semester.

Attendance at Pro Events will be confirmed within the Pro Events Tracker in the virtual C2C.
