Course Description: An examination of race in the context of the criminal justice system. Emphasis on the treatment of racial minorities as victims and offenders by law enforcement, courts, and corrections. In this class, we will examine current research and theories of racial and ethnic discrimination within America's criminal justice system.

Course Structure. This class is a hybrid class, which means that some classes will require students to complete coursework online instead of in the classroom. This includes videos, assignments, discussions, and exams, which should all be submitted on Canvas. Please note that I will not accept any assignments completed outside of class in any other form, such as paper or email submissions.

Between one-fourth and one-half of the classes are conducted online, which means that approximately 8 to 16 classes out of the total number of classes will be conducted online. Please refer to the class schedule and Canvas for updates. The online portion of the class will be delivered through the course management system Canvas. You will use your UWSP account to log in to the course from the Canvas Login Page. If you haven't already activated your UWSP account, please visit the Manage Your Account page to do so.

A large portion of the in-person class will be devoted to discussion and group activities. Students are expected to have completed the assigned readings prior to coming to class (see the attached schedule of readings and on Canvas). Students are expected to contribute their viewpoints and opinions during class discussions. Due to the active role students play in this course, regular attendance is strongly encouraged. While attendance may not be checked daily, excessive absence will negatively affect your final grade. Students are responsible for all information and assignments missed during their absences--including announcements concerning any changes in the course schedule.

Courses Learning Outcomes. By the end of this course, students should be able to:

- Understand how race and ethnicity are central to crime and criminal justice.
- Know the difference between race and ethnicity.
- Understand the different theoretical explanations for the racial and ethnic gap in offending and victimization.
- Understand the nature and extent of inequality in American society with respect to racial and ethnic minorities.
- Explain the most important issues related to police and people of color.
- Explain how race and ethnicity continue to be taken into consideration during the jury selection process.
- Understand that there are significant racial differences in attitudes toward capital punishment.
- Have a statistically accurate understanding of who is in prison and the racial and ethnic composition of the prison population.
