Course Description

• Introductory Psychology provides a survey of the major areas of study in psychology such as: motivation, learning physiology, human development, social psychology, abnormal behavior, perception, memory, cognition/thought, and treatment. This will be an experiential course where students examine and provide examples of the concepts covered from their own lives and experience.

• We will use a Hyflex model which means students have the option of attending in the classroom, via Zoom during the scheduled class time and participate in discussion (synchronous). Or, students may treat the class as an online course and watch the recorded lectures at your leisure (asynchronous). Assignments will be due each Sunday night before midnight.

Grading Scale

Discussion Board: Students will be graded weekly for their participation in class. Each week, students will be expected to read the chapters assigned, along with any supplemental material and answer the weekly discussion question on the class discussion board. In addition, students will comment on at least two fellow student threads contributing to in-class discussion. With the student responses, state your opinion then provide at least 2 supporting statements. **Simple, one or two line responses do not earn points.** Please be thorough in your responses. Discussion board answers and student responses are worth 4 points weekly.

Weekly Questions: Answers to the weekly questions should be 1-2 full paragraphs each. These observations should be written at college level and devoid of grammar, punctuation and spelling errors. Thoughts should be presented in a scholarly manner. Questions are worth 11 points each week. You MUST create your work in Word to take advantage of spell/grammar check then copy/paste into Canvas.

An extra credit point will be earned if your answers to the weekly questions are posted by midnight, Wednesday of each week. These will be the only extra credit points available. Turn them in via Canvas before Sunday, midnight each week.

QUIZZES: Each week, a short quiz (10 questions or less) will be posted midweek on the text material for that week. The questions will be in multiple choice, true/false or short answer format. They will be set up as timed completion and will be due before midnight each Sunday. It is up to each student to keep up with the reading and weekly quizzes. There will be no make-up quizzes.

EXAMS: There will be 3 exams during the semester including the final exam. Exams will count as 20% of your final average. The first two exams will be worth 60 points each and the last, 80 points. If you must be absent for the exam for any reason, you must contact me <u>no later than the day before the test</u> to make arrangements to make up the exam. Otherwise, 0 points will be recorded and your grade computed accordingly. The last exam will be proctored. They will be proctored in class for lecture students. If an online student, you will be expected to make arrangements for your proctored exams.

Attendance

Attending class will likely be the single most important factor in determining your performance and grade in the course, so plan to attend every class. In most class meetings you will have at least one project, exercise, test, and/or discussion that will impact your grade, and your class discussions will count toward participation. The relationship between attendance and achievement in education has been extensively documented in peer-reviewed research. *I am not able to re-teach the material to you in the event that you are absent, but you can ask a classmate to share notes.* Any exceptions to the attendance policy should be confirmed in writing.

Attend all your classes regularly. We do not have a system of permitted "cuts."

If you decide to drop a class, please do so using myPoint or visit the Enrollment Services Center. Changes in class enrollment will impact your tuition and fee balance, financial aid award and veterans educational benefit.

During the first eight days of the regular 16 week term, your instructor will take attendance. If you are not in attendance, you may be dropped from the class. You are responsible for dropping any of your enrolled classes.

- If you must be absent during the term, tell your instructor prior to the class you will miss. If you cannot reach your instructor(s) in an emergency, contact the Dean of Students Office at 715-346-2611 or DOS@uwsp.edu.
- If you are dropped from a class due to non-attendance, you may only be reinstated to the class section using the class add process. Reinstatement to the same section or course is not guaranteed. - If you do not make satisfactory arrangements with your instructors regarding excessive absences, you may be dismissed. If you are dismissed from a class, you will receive an F in that course. If you are dismissed from the University, you will receive an F in all enrolled courses.

Late Work

I do not accept late work other than in the case of documentable emergencies such as medical treatment. Please be mindful of deadlines as I want you to be successful this semester.

Absences due to Military Service

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:
- (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
- (b) Uses unauthorized materials or fabricated data in any academic exercise;

- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;
- (e) Engages in conduct aimed at making false representation of a student's academic performance; or
- (f) Assists other students in any of these acts.
- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
 - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
 - Stealing examinations or course materials
 - Submitting, if contrary to the rules of a course, work previously presented in another course
 - Tampering with the laboratory experiment or computer program of another student
 - Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

Students suspected of academic misconduct will be asked to meet with the instructor to discuss the concerns. If academic misconduct is evident, procedures for determining disciplinary sanctions will be followed as outlined in the <u>University System Administrative Code</u>, <u>Chapter 14</u>.

Other Campus Policies

FERPA

The <u>Family Educational Rights and Privacy Act</u> (FERPA) provides students with a right to protect, review, and correct their student records. Staff of the university with a clear *educational need to know* may also have to access to certain student records.
