Course Description

This course examines the types, settings, challenges, and issues facing specific programs; including Early Childhood (infant/toddler, preschool, and kindergarten), childcare, Head Start, Early intervention, and others. This course also explores brain-based, play-based learning environments, childcare regulations, poverty, and diversity. Practicum experience (10 hours) in an early childhood setting is required.

Course Learning Outcomes

- 1.) Students will read, review, and connect findings from assigned readings about different types of programs for children and families.
- 2.) Students will describe an appropriate learning environment based on class readings and discussions, with a knowledge of theoretical perspectives on child development.
- 3.) Students will observe/design social programs based on social trends, needs, and diverse challenges confronting children and families in present day America.

Description of Course Assignments

Childcare/Early Childhood Observations

30pts.

Students will complete several observations (45-60 minutes each) and complete the necessary form given by the instructor. They will then write an observation summary paper after completing all 10 hours.

Interview with Childcare Provider

50pts.

Students will contact a director or assistant director of a childcare facility and interview them. Students will receive a list of questions along with a recording sheet. After the interview is complete, students will use their notes to create a presentation highlighting their discoveries.

Guided Questions: Play-Based Book

50 pts.

Students will read one of the approved play-based books and complete the guiding questions and/or journal prompts.

Assignment Criteria/Late Work

Quality: Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. More than one grammatical/mechanical error per page (on average) does not constitute "A" work. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

Originality: All work must be <u>original for this class</u>. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7th edition.

Submission Format: Unless otherwise noted, all assignments must be submitted **electronically** on CANVAS uploaded in student folder **on or before the due date by 9:00am**. Each assignment must be submitted as a single WORD document. The top page of each paper must have name, date, course number, and assignment name.

Timeliness/Late Work: One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late (see rubrics). A failing grade, or an incomplete will be given for noncompletion.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:

- (b) Uses unauthorized materials or fabricated data in any academic exercise;
- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;
- (e) Engages in conduct aimed at making false representation of a student's academic performance; or
- (f) Assists other students in any of these acts.
- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
 - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
 - Stealing examinations or course materials
 - Submitting, if contrary to the rules of a course, work previously presented in another course
 - Tampering with the laboratory experiment or computer program of another student
 - Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

Students suspected of academic misconduct will be asked to meet with the instructor to discuss the concerns. If academic misconduct is evident, procedures for determining disciplinary sanctions will be followed as outlined in the <u>University System Administrative Code</u>, <u>Chapter 14</u>.
