Course Description

This course will examine curriculum and methods for using and implementing_expressive arts such as art, drama, music, movement to enhance a child's development and learning often done through play. This course requires a "hands-on" approach as students will actively participate and lead creative activities. Practicum/field experience of 15 hours in an early childhood setting is a course requirement.

Course Learning Outcomes

- 1.) Students will critically analyze key theoretical frameworks in early childhood education, such as Piaget's stages of cognitive development or Vygotsky's socio-cultural theory, to inform their teaching practices.
- 2.) Students will integrate academic content from various subjects (e.g., science, math, language arts) into creative activities, fostering cross-disciplinary learning experiences for young children.
- 3.) Students will create inclusive and culturally responsive learning environments, acknowledging and respecting the diverse backgrounds and needs of young children and their families.

Description of Course Assignments

Investigating Current Curriculum/Methods

40 pts.

Students will gather information about curriculum and methods that are currently in use and what ECE teachers think about them. Students will interview two ECE teachers who are currently teaching in an area of early childhood; one of which is their cooperating teacher for practicum/field experience. Questions, specifics, and rubric available in CANVAS.

Weekly Assignments (8 total)

80 pts. (10 pts. each)

Throughout the semester there will be assignments related to the course readings and content to help you gain the knowledge, skills, and disposition that are needed to effectively integrate creative/expressive activities into the classroom. You will show evidence of your knowledge and understanding by completing tasks either individually, with partners, or in small groups. Assignment specifics and rubrics available in CANVAS.

Peer Teaching Lesson

Each unit plan group will peer teach one lesson in class. The lesson chosen must highlight one of the expressive disciplines/topics (music, movement, drama, art) addressed in class. There will be two lesson presentations given during three class periods and each group will have 25 minutes to teach the activity to the class as if we were elementary-aged students. Each group must provide a copy of the lesson plan to the instructor prior to the class period in which they are presenting the activity. A rubric for this assignment is available on Canvas.

Unit Plan 100 pts.

Students will use the Understanding by Design (UbD) framework to develop an extensive unit plan on the theme assigned during class focusing one lesson on each of the following areas: Art, Creative Dramatics, Social Studies, Music, and Language Arts at the 3K, 4K, kindergarten, first, second, or third grade level. Students should integrate diversity and differentiation within the entire unit plan. Unit plan specifics and rubric available in CANVAS. **This is the signature assessment and therefore students need a score of 80% or higher for a passing course grade.

Assignment Criteria/Late Work

Quality: Papers/Assignments must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. More than one grammatical/mechanical error per page (on average) does not constitute "A" work. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

Originality: All work must be <u>original for this class</u>. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7th edition.

Submission Format: Unless otherwise noted, all assignments must be submitted electronically on CANVAS uploaded in student folder on or before the due date by noon. Each assignment must be submitted as a single WORD document. Each assignment must have the student's name, date, and course number or no grade/feedback will be provided.

Timeliness/Late Work: One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late. A failing grade, or an incomplete will be given for noncompletion. Any and all course work for the semester is due at the beginning of the final course day; any work submitted after this time will not be accepted. You have 6 days from receiving feedback to revise and resubmit any assignment except for the signature assessment.

<u>Attendance</u>

Attending class will likely be the single most important factor in determining your performance and grade in this course, so plan to attend every class. Your attendance and participation is essential. Collaboration with your peers outside class is strongly encouraged. All students are expected to read the assigned material before each class session. Students may be asked to discuss textbook and lecture material in small groups.

Students' final grade will be dropped in the event of excessive absences. On the third absence ("excused" or "unexcused"- I do not differentiate between the two), a student's final grade will be dropped one half letter grade (for example, A- to B+) At every second absence thereafter (on the 5th, 7th, 9th, 11th, etc. total absences) a student's letter grade will be dropped one half letter grade further (for example, on the 5th absence the earlier mentioned A- will drop to a B+. On the 7th absence that B+ would drop again to a B. On the 9th absence the original A- will drop to a B-.) Please note that failure to complete the assigned activity for any online class will be counted as an absence and participation points for that session will not be earned. Accommodations can be made for absence(s). If you will be missing class, before or within 1 day of your absence you must request an alternative assignment that you can complete and hand in or your absence will count as one of your two unpenalized ones. If you feel ill, please err on the side of caution and stay home.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:
- (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
- (b) Uses unauthorized materials or fabricated data in any academic exercise;
- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;
- (e) Engages in conduct aimed at making false representation of a student's academic performance; or
- (f) Assists other students in any of these acts.
- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another

- Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
- Stealing examinations or course materials
- Submitting, if contrary to the rules of a course, work previously presented in another course
- Tampering with the laboratory experiment or computer program of another student
- Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

Students suspected of academic misconduct will be asked to meet with the instructor to discuss the concerns. If academic misconduct is evident, procedures for determining disciplinary sanctions will be followed as outlined in the University System Administrative Code, Chapter 14.

FERPA
