## **Course Description**

Using the Understanding by Design (UbD) framework, this course explores "hands-on" activities in art, music, creative movement, and creative dramatics in early childhood classrooms. The implications of specific theories (Piaget, Vygotsky, Gardner, Erikson, and Reggio Emilia approach) are also discussed. Findings from brain research in early childhood classrooms, impact of technology, globalization, diversity, and intentional play are also integrated in the course. Practicum experience (15 hours) in an early childhood setting is required.

## **Course Learning Outcomes**

- 1.) Students will understand that early childhood theorists provide a framework for making informed decisions in curriculum planning in early childhood classrooms.
- 2.) Students will understand that findings from research in brain development and social-emotional growth guide early childhood classroom practices.
- 3.) Students will understand the centrality of STEM, Globalization, and Diversity/Ant-Bias practices in early childhood classrooms underscores Developmentally Appropriate Practices.

# **Description of Course Assignments**

## **Unit Plan Check-in**

10 pts

Students will work with their unit plan group to complete a draft of a rationale and Stage 1 of the UbD Unit Planning Template. Completing this assignment will help students identify what expressive art content and skills are important to teach and keep them focused on the big ideas/enduring understandings.

#### **Peer Teaching Lessons**

60pts. (30 pts each)

Each unit plan group will peer teach two lessons from their unit plan to teach in class. The lesson chosen must highlight one of the expressive disciplines/topics (music, movement, drama, art) addressed in class. There will be two lesson presentations given during three class periods and each group will have 25 minutes to teach the activity to our social studies methods class as if we were elementary-aged students. Each group must provide a copy of the lesson plan to the instructor prior to the class period in which they are presenting the activity. A rubric for this assignment is available on Canvas.

Unit Plan 100 pts.

Students will use the Understanding by Design (UbD) framework to develop an extensive unit plan on the theme "friendship" or "family" in at least five curricula areas (art, music, movement, creative dramatics, literacy, math) at the kindergarten, first, second, or third grade level. Students should

integrate diversity and differentiation within the entire unit plan. Unit plan specifics and rubric available in CANVAS.

#### **Expressive Arts Focus Summary**

40 pts.

Students will prepare a formal paper on a chosen curriculum in Expressive Arts. The paper will explore the impact of this curriculum on learning experiences within their preclinical classroom. Students will identify curriculum and provide theoretical rationale of the significance of this curriculum in early childhood. Students will then summarize how the curriculum was set up and utilized, while also suggesting ideas to enrich the curriculum. Students will then reflect on what they learned while keeping a weekly journal on learning centers.

### **Attendance & Participation**

140 pts. (5pts. for each class)

You are required to attend each class period and come prepared to discuss readings and collaborate with your peers on course activities. See attendance information further down.

## Assignment Criteria/Late Work

**Quality:** Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. More than one grammatical/mechanical error per page (on average) does not constitute "A" work. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

**Originality:** All work must be <u>original for this class</u>. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7<sup>th</sup> edition.

**Submission Format:** Unless otherwise noted, all assignments must be submitted **electronically** on CANVAS uploaded in student folder **on or before the due date by 2:00pm**. Each assignment must be submitted as a single WORD document. The top page of each paper must have name, date, course number, and assignment name.

**Timeliness/Late Work:** One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late. A failing grade, or an incomplete will be given for noncompletion.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:

- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;

- (2) Examples of academic misconduct include, but are not limited to:
  - Cheating on an examination
  - Collaborating with others in work to be presented, contrary to the stated rules of the course
  - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
  - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
  - Stealing examinations or course materials
  - Submitting, if contrary to the rules of a course, work previously presented in another course
  - Tampering with the laboratory experiment or computer program of another student
  - Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is

submitted or performed by a person other than the student under whose name the work is submitted or performed.
