<u>Course Description</u>: This course will introduce you to the basic ideas of econometrics, with a focus on the regression analysis. We will discuss regression analysis, hypothesis testing, choosing econometric variable and functional form, multicollinearity, serial correlation, heteroskadasticity, as well as other topics. After the course you should be able to apply linear regression model to economic data as well as analyze the outcome of such models.

After completing the course students should be able to:

- Define OLS and its assumptions
- Apply linear regression model to analyze economic data
- Run multiple regressions in STATA or SPSS
- Analyze the outcome of multiple regression models

Exams: There is one midterm exams and a final exam. Exams will emphasize analytical and problem solving skills and will cover the textbook chapters covered as well as any additional material presented in class. The final exam is not comprehensive but the knowledge of the former chapters should be important tool for the final. Makeup exams will not be offered without a university sanctioned excuse. Approval for a makeup must be obtained before the date of the exam and should not be taken as given.

<u>Term paper</u>: Main focus of this course is to provide practical guidance of econometric methods through hands on experience. The term paper should consist of data summary, economic model, regression tables, hypothesis testing and analysis of the outcome. Any kind of publicly available data is permissible (does not need to be economic variables). The draft paper will be due two weeks before the final exam and the final paper will be due one week before the final exam.

<u>Assignments:</u> assignments will be posted online on D2L throughout the course. Assignments are designed to offer hands-on practice with the material and the software (STATA). There will be partial markings for partly correct answers. The assignments should be submitted through D2L on or before the due date.
