Course Description

This course examines historical perspectives and instructional strategies for teaching social studies in grades PreK-3. As learners and teachers, students enrolled in this course will examine, prepare, and present their perspectives on the STRANDS of Social Studies, e.g., history, geography, politics, economics, and behavioral sciences through hands-on learning activities. As students construct their knowledge and understanding of social studies, they, in turn, will guide the learning experiences of young learners in early childhood classrooms. The goal of this course is to support students' efforts in teaching social studies to a community of learners in early childhood classrooms.

Course Learning Outcomes

- 1) Students will be able to identify, describe, and prepare hands-on learning activities reflective of the five STRANDS of Social Studies, e.g., history, geography, politics, economics, and behavioral sciences.
- Students will create a detailed and comprehensive unit plan that has hands-on learning activities that integrate Social Studies STRANDS in exploring a specific theme for learners in early childhood grades.

Description of Course Assignments

Group Facilitation

30pts.

Each group will serve as discussion facilitators to start a class for approximately 20 minutes. The discussion should focus on specific course content and readings as related to the class period. A rubric is available on CANVAS

Unit Plan Check-in

10 pts

Students will work with their unit plan group to complete a draft of a rationale and Stage 1 of the UbD Unit Planning Template for your unit topic. Completing this assignment will help students identify what social studies content and skills are important to teach and keep them focused on the big ideas/enduring understandings.

Peer Teaching Lesson

30pts.

Each unit plan group will choose a lesson from their unit plan to teach in class. The lesson chosen must highlight one of the social studies disciplines/topics (geography, history, political science, economics, and behavioral sciences) addressed in class. There will be two lesson presentations given during three class periods and each group will have 25 minutes to teach the activity to our social studies methods class as if we were elementary-aged students. Each group must provide a copy of the lesson plan to the instructor prior to the class period in which they are presenting the activity. A rubric for this assignment is available on Canvas.

Final Unit Plan

30pts.

Using the UbD template and working in small collaborative groups, students will develop a comprehensive unit plan on a theme appropriate to an early childhood classroom. Your unit plan will include five to six lesson plans, a performance assessment, and an annotated bibliography. Specific details and a rubric are available on CANVAS.

Assignment Criteria/Late Work

Quality: Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by

concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. More than one grammatical/mechanical error per page (on average) does not constitute "A" work. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

Originality: All work must be <u>original for this class</u>. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7th edition.

Submission Format: Unless otherwise noted, all assignments must be submitted **electronically** on CANVAS uploaded in student folder **on or before the due date by 9:30am**. Each assignment must be submitted as a single WORD document. The top page of each paper must have name, date, course number, and assignment name.

Timeliness/Late Work: One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late. A failing grade, or an incomplete will be given for noncompletion.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:
- (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
- (b) Uses unauthorized materials or fabricated data in any academic exercise;
- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;
- (e) Engages in conduct aimed at making false representation of a student's academic performance; or
- (f) Assists other students in any of these acts.
- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
 - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
 - Stealing examinations or course materials
 - Submitting, if contrary to the rules of a course, work previously presented in another course
 - Tampering with the laboratory experiment or computer program of another student
 - Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

Students suspected of academic misconduct will be asked to meet with the instructor to discuss the concerns. If academic misconduct is evident, procedures for determining disciplinary sanctions will be followed as outlined in the University System Administrative Code, Chapter 14.
