## **I.Purpose and Description of Course:**

• The purpose of this course is to further develop and discuss the utilization of appropriate classroom curriculum and materials, teaching strategies, curricular adaptations, and methodology at elementary through secondary levels in core content areas (reading, writing, and mathematics) for teaching students with learning, emotional, and intellectual disabilities along with other areas of exceptional educational needs. This course will allow students to research, question, understand and apply methods/strategies from the classroom and readings to individual and group work.

**II.Student Learning Outcomes:** At the completion of this course, students who have committed to active engagement will be able to

- Implement teacher-directed instructional activities in a classroom setting with students who have been identified as having diverse learning needs.
- Write a lesson plan which includes evidence-based instructional strategies to meet the individual and diverse developmental needs of students with exceptionalities.
- Identify and explain specialized and general reading, writing, and mathematics methods and curriculum used in inclusive and specialized educational settings.
- Prepare a comprehensive instructional plan including backwards planning (UbD) components and a lesson plan for a student with an exceptionality.

• Read and analyze current research and programs in special education.

## **UWSP 14.01 Statement of principles.**

The board of regents, administrators, faculty, academic staff and students of the university of Wisconsin system believe that academic honesty and integrity are fundamental to the mission of higher education and of the university of Wisconsin system. - (c) Forges or falsifies academic documents or records;

- (2) Examples of academic misconduct include, but are not limited to: cheating on an examination; collaborating with others in work to be presented, contrary to the stated rules of the course; submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another; submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas; stealing examinations or course materials; submitting, if contrary to the rules of a course, work previously presented in another course; tampering with the laboratory experiment or computer program of another student; knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

## XIX.Confidentiality:

• Learning requires risk-taking and sharing ideas. Please keep your classmates' ideas and experiences confidential outside the classroom unless permission has been granted to share them.

## **XX.Religious Observances**

- Participate in class discussions and activities. Active participation in class is an important part of the learning process and development of educational professionalism.
- Conduct yourself as a professional educator should conduct him/herself.

- Apply high levels of scholarship and ethics to explore matters in regard to educating students with special needs.
- Make an appointment to discuss questions regarding grades/other concerns with me privately.
- Understand and display growth and development of the UWSP "Teacher Dispositions."
- You are welcome to take notes on tablets and/or laptops, however, I view usage unrelated to immediate course activities as unprofessional and disrespectful and will deduct attendance/participation points. This means you should abstain from looking up information about the final exam during our third day of class or even teaching-related videos/posters on Facebook, for example, until break time or after our meeting for the day has ended.

• Late Work Policy: Submit all assignments by the posted due date to the appropriate location by 11:59 pm. Assignments turned in within 24 hours after the due date will be downgraded 10% from the earned grade. Assignments turned in within 1 week of the due date will be downgraded 30%. Assignments turned in after 1 week will be downgraded 50% from the earned grade. Please ask before the assignment is due if you need an extension; in most cases I will grant one.

## XXVII.Assignments:

• The course requirements are designed to help you foster proficiencies, demonstrate competence or provide evidence of the above outlined standards and student learning

outcomes. Please note that the Exceptionalities Assignment, Teaching Method assignment, Practicum Log, and Understanding by Design Plan & Reflection are Signature Embedded Assessments and must be turned in in order to pass this course regardless of your total points earned or final percentages. In other words, failure to complete them will result in course failure. Do not submit google doc links for your assignments. More detailed assignment descriptions can be found in Canvas.

### • Attendance:

- In this course you should strengthen your abilities to collaborate with your peers and become a contributing member of a dynamic learning community. Your attendance and participation is essential. Collaboration with your peers outside class is strongly encouraged. All students are expected to read the assigned material before each class session. Students will frequently be asked to discuss textbook and lecture material in small groups.
- Attending class will likely be the single most important factor in determining your performance and grade in the course, so plan to attend every class. In most class meetings you will have at least one project, exercise, test, and/or discussion that will impact your grade, and your class discussions will count toward participation. The relationship between attendance and achievement in education has been extensively documented in peer-reviewed research. I am not able to re-teach the material to you in the event that you are absent, but you can ask a classmate to share notes. Any exceptions to the attendance policy should be confirmed in writing.
- Students will be required to attend a 1:1 meeting with me in the event of excessive absences. I consider missing 5 or more classes to be excessive. Excessive absences may result in your final letter grade being lowered.
- Please refer to the "Absences due to Military Service" and "Religious Beliefs Accommodation." Additionally, below are attendance guidelines as outlined by the <u>UWSP registrar</u>:
  - Attend all your classes regularly. We do not have a system of permitted "cuts."
  - If you decide to drop a class, please do so using accesSPoint or visit the Enrollment Services Center. Changes in class enrollment will impact your tuition and fee balance, financial aid award and veterans educational benefit.
  - During the first eight days of the regular 16 week term, your instructor will take attendance. If you are not in attendance, you may be dropped from the class. You are responsible for dropping any of your enrolled classes.

- **Participation:** Students will earn participation points for in-class activities. I will deduct points for cell phone use or inappropriate laptop/tablet use during class time. Communicate with me before class if there is a reason that you will need to have your cellphone visible during class.
- **Exceptionality Presentation:** Create and give a presentation of one of the thirteen disability categories. Include information about eligibility, the definition, characteristics, and adaptations. \*You must earn 70% or higher to pass the course
- **Chapter Assignments:** Throughout this course you will be expected to complete learning activities corresponding to textbook chapters. Types of tasks may include communicating via email, completing basic internet searches, downloading and uploading documents to Canvas, reading documents online, viewing online videos, participating in online discussions, completing tests online, and participating in asynchronous online discussions. You will earn points for participating in and submitting various activities. Although most of the activities are due Sundays, you may work ahead and complete them/turn them in early.
- **Practicum Experience Assignment:** This course requires a 15 hour practicum with a special education teacher providing instruction to a student with an IEP. Upon the completion of your practicum hours, you will write a paper, reflecting on the experience and connecting it to the course topics. \*You must submit documentation of 15 hours in order to pass the course.
- **Teaching Method Assignment:** Research the math curriculum your practicum placement uses. \*You must earn 70% or higher to pass the course
- **Final Project -Understanding by Design Plan and Reflection (formerly the Instructional Plan):** Over the course of the second part of the semester, students will use information from a student profile given to them to engage in backwards planning, focusing on assessment methods, content/learning materials, and learning activities. This assignment requires students to also submit a lesson plan which will include an evidence-based strategy for said student and written

reflections on the planning, instruction, and assessment phases of delivering instruction. \*You must earn 80% or higher to pass the course.
