Description of the course:

This course is designed to analyze critical issues in education; their ideological and social bases. This is a 100% on-line course with no required class discussions. The analysis of your philosophy is a self-reflection of teaching practice. Standards: Intasc Teaching Standards 9 & 10, Wisconsin Administrator & Pupil Services 7.

II. Objectives

In this course participants will analyze their own philosophy of education relative to past and current educational inquiry. The course is designed in seven parts addressing major areas of philosophical inquiry. A single capstone assignment of a minimum **seven-page** synthesis paper will determine your grade in this course. The paper has seven modules or parts and each module will create the content for the final paper. There are no deadlines in this course, however, please plan to pace your work throughout the summer so you can enjoy the course. It is permissible to do a single submission of a final paper at any time during the course timeline, but you will not receive incremental feedback about your work if you choose to do the course in this manner. Your course grade is based solely on the quality of your final paper.

- Length: Suggested essay lengths are described in each module. Original writing is required; quotations and paraphrases must be cited.
- Style: essays should follow generally-accepted rules of style (e.g., American Psychological Association *Publication Manual*, Chicago *Manual of Style*).
- Material: each paper segments are responses to writing prompt questions.
 The writing prompts are clearly articulated in the modules.

Discussions: Please contribute to the discussions on Modules 4 and 5. You are required to post to the discussion board and to respond to at least one person on the discussion string for your grade. Minimum of a paragraph for suggested length.

Final Paper: The final paper will be a compilation of the paper parts. It is important that you put the final paper together using appropriate transitions. This will determine your overall quality grade.
