Course Description

From the catalog: "Read, select, and present materials suitable for elementary school readers." The focus of this class will be middle-grade fiction, materials appropriate for children in grades 3 through 6.

Course Goals:

- (Re)discover the pleasures of children's literature
- Be familiar with the history of children's literature
- Know past and present authors of stories for children
- Explain the educational value of different genres in children's literature
- Recognize and analyze the use of literary elements in children's literature
- Evaluate children's stories on the quality of writing and the needs of students
- Be familiar with issues in selecting and teaching various categories of children's books
- Apply techniques for discussing literature and incorporating literature into the classroom

Technology:

In order to take this class, you must have a reliable internet connection as well as a computer with video and audio. There will be times when computers don't work, when internet goes down, etc. We will try to be flexible with each other. When these situations arise, communication is important. As soon as you (or I) have e-mail, explanations should flow both ways.

Attendance

Although attendance is not mandatory, it is strongly encouraged. If you miss a class, it is your responsibility to contact me to discover what you missed and what alternative graded assignment is available.

Note Taking: When the semester is finished, you will return your rental textbook and no longer have access to its content. As such, I want you to take notes on readings, so you will have that information later. Additionally, you will take notes on literature circles and peer presentations. The "grade" is based on content (not good writing, neatness, etc.) -- basically whether or not you have actually done the work and taken down enough information for it to be useful to you three or five years from now. You will upload your notes as a single file. You can take photos of notebook pages and convert them to a single pdf (genius scan app, etc.) or you can import them into a word document. Take notes by hand; you will remember material much better this way.

Communication

I will use your university email account to communicate with you outside of class. <u>Please check your email regularly</u>. I will try to respond to your emails within 24 hours, but there may be some occasions when I am offline all weekend. If my Zoom office hour times are not open for you, I am happy to work with you to find a time that is convenient for us both.

If you have questions about an assignment, do NOT email me your assignment and ask me to look at it. I am happy to meet with you during my office hours to go over any questions you may have.

Plagiarism:

Plagiarized occurs when you use another's words or ideas without properly citing them. Every assignment will be submitted to plagiarism-checking software (the canvas dropbox). I will fail work that is plagiarized and report offenders to the dean's office.
