COURSE DESCRIPTION

This course will cover child life related topics for aspiring child life specialists. The course will meet the requirements set forth by the ACLP to cover topics including: official documents of the ACLP/CLCC, scope of practice, impact of illness, family centered care, therapeutic play, & preparation (3 credits)
