Course Description:

Introduction to cancer epidemiology and pathogenesis with an emphasis on interprofessionalism. Through lecture, assignments/case studies, literature reviews, etc., students will develop knowledge about the impact of cancer on individuals and families; as well as the etiology, pathogenesis, morphology and clinical course of cancer via select organ systems.

Texts:

No texts will be required. You will be expected to review websites as discussed in class for information pertinent to the course content. Other learning materials will be handed out in class or obtained through D2L.

Learning Outcomes:

When this course ends, learner participants will be able to:

- 1) Differentiate between various types of cancer according to organ systems to include etiology, pathogenesis, morphology, and clinical course.
- 2) Explain routes of cancer spread.
- 3) Summarize risk reduction strategies for preventing the development of Cancer.
- 4) Develop an appreciation for and understanding of interprofessionalism.

Course Format:

This course uses multiple methods of learning and assessment, focusing on active learner engagement.

To assure your success in this course, several strategies are recommended:

1. Attend all classes! Topical discussions and activities taking place during class time reinforce learning, covers material more in-depth, and assist in developing test-taking strategies & abilities. You are expected to participate and failure to do so will affect your grade.

2. Complete all assigned readings prior to the class in which they are covered. These will be outlined in the class schedule and/or given in class.

3. Print the **Course Calendar** to stay organized.

4. Written work must be computer generated with your name in the top right hand margin. Specific guidelines for each assignment will be discussed in class.

5. Read your emails and the announcements in D2L. You are responsible for any information in either of these formats. Only campus email addresses will be used.

Assignments:

Article summaries, case studies, etc. will be completed and turned in for grading. Due dates are indicated on the schedule posted to D2I. Article summaries should be ½ page to 1 page summaries of a peer-reviewed literature article **of the students choosing on the appropriate weekly content** as indicated in the course schedule. Students should also come prepared to discuss the article.

Attendance/Discussion/Professionalism:

Actively participating in course discussions is expected and requires your attendance at all course sessions. Absence from class is <u>only excused</u> with written documentation (doctor's excuse, printed obituaries, coaches' note for games).

Quiz

A comprehensive quiz will be given online utilizing D2L. The quiz will cover the objectives listed at the beginning of lecture ppts. The due date for the quiz is listed in the course schedule.

Cancer Paper:

Students will write a position paper on the topic of cancer. More specific details including a rubric will be provided on D2I.

Group IP Project:

Students will work in interprofessional teams (depending on the make-up of the class) on a group project. Students will prepare a ppt. presentation based on a cancer of their choosing. Presentation order will be drawn randomly. See schedule for presentation dates.

Attendance for the group project presentations is mandatory and presentations will extend into finals week; attendance will be taken during the final exam period which will count toward student grades (Missing the final exam class session will result in a loss of 50% of the student's attendance grade).

Missed/Late Work Policy

Missed/late work (assignments, projects, exams, etc.) will receive a zero if not completed by the scheduled due dates or scheduled exam periods unless the student provides the instructor with a doctor's note, coaches note, obituary, etc., as deemed appropriate by the instructor. Students with proper documentation will be given no more than 72 hours, from the date of the document, to complete all missed work. It is the student's responsibility to provide the instructor with the documentation and schedule make-up exams and /or submit late assignments, etc. within the 72 hour time-frame; failure to do so will result in a zero.

Note: Having to work is not an acceptable reason for missing class and the absence will be deemed unexcused, and result in a zero for any missed school work.
