Course Description and Prerequisites

"Independent study covering one or more health or wellness concerns. May be repeated for credit." A major goal of this course is to help you begin thinking about the medical issues in a more nuanced way, beyond sick patients and physicians treating symptoms to help patients get well. Many health conditions arise due to a combination of factors – genetics, education, socioeconomic status, community/place of residence, and so on, and these factors may also influence the preventative measures and treatments available to and acceptable to an affected individual. Similarly, health care providers are often constrained by time with patients, limitations on the treatments that insurers will pay for, and policies instituted by employers, licensing or accrediting bodies, or government agencies. A major goal of this course is to increase your understanding of the socioecological model and how complex healthcarerelated problems occur at individual, interpersonal, institutional, and policy levels. At the Medical College of Wisconsin (MCW), medical case studies are being used in courses taken by medical students to help them better understand these kinds of complexities in providing medical care to patients. We will use two MCW case studies that have been adapted somewhat for our use – one involving diabetes and another involving dementia and Alzheimer's disease. Prerequisite: Instructor Consent.

Course Objectives and Learning Outcomes

- 1. Be able to search scientific literature and use the literature for a research presentation.
- 2. Be able to communicate scientific information clearly orally and in writing.
- 3. Describe the social, economic, political, and institutional factors associated with diabetes.
- 4. Describe the social, economic, political, and institutional factors associated with dementia.

Course Expectations

Students are expected to be present at all virtual class meetings. Discussion-based assignments will be done in class sessions. So, unexcused class absences may negatively affect a student's course grade. Please discuss with your instructor in advance the reason for any absences which you feel should be excused. The instructor and students are expected to show respect for everyone in the class. Reading and written assignments should be completed before the designated class meeting time. The work that each student hands in should be in his or her own words. For effective communication, students are expected to type and spell-check your work on assignments. Students should daily check their UWSP student email account and UWSP Canvas as some class announcements, handouts, and reading assignments will be given using these technologies. Scores on

assignments will be posted on Canvas, and an estimation of your course grade will be kept updated during the semester on Canvas.

Graded Activities

You can earn a total of 290 points in this course, as follows:

- 140 pts (20 pts/session) Attend all class meetings and participate actively in each class period.
- 150 pts (25 pts/session except the first class meeting) Submit written responses to the discussion questions about the assigned reading. Your responses will be due before the start of class. I will evaluate your answers for correctness, quality of writing, thoroughness, thoughtfulness, creativity, and evidence of honest effort.
