Description: Basic principles of ecology and application of those principles to the management of natural resources.

Learning outcomes: To gain hands-on experience with techniques and methods used by natural resource scientists, including data collection and analysis, field techniques, report writing, data visualization, library resources, and teamwork.

Grading: The lab portion constitutes 40% of your NRES 151 grade. The tentative schedule below indicates the approximate point values for each graded activity.

Attendance policy: Attendance is expected, and you will not do well if you miss class. There may be points associated with lab participation and missed labs will translate into missed points on quizzes, assignments, and the exam.
