<u>Logistics:</u> NRES 250 lab will be 100% in-person. It will consist of a combination of classroom lecture material and classroom and outdoor activities. You will be conducting all activities as part of an assigned crew. It will be up to your crew to obtain the gear needed for each activity from the stockroom before each class meeting. Be sure to have your student ID to pick up your crew's gear.




Figure 1. Campus map showing the TNR building (12) and Old Main (1) and meeting sites labeled A, B, and C.
