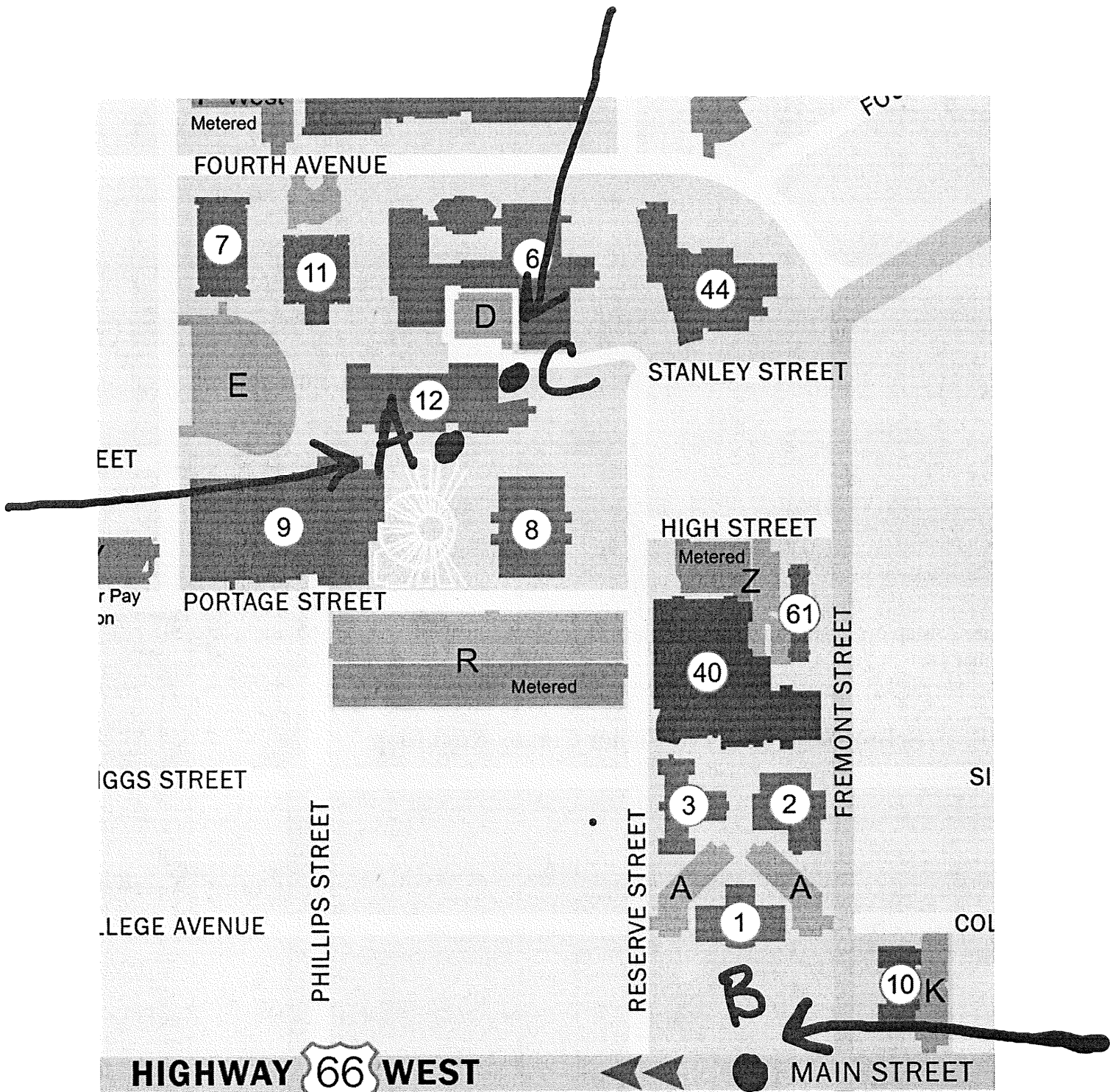


Figure 1. Campus map showing the TNR building (12) and Old Main (1) and meeting sites labeled A, B, and C.

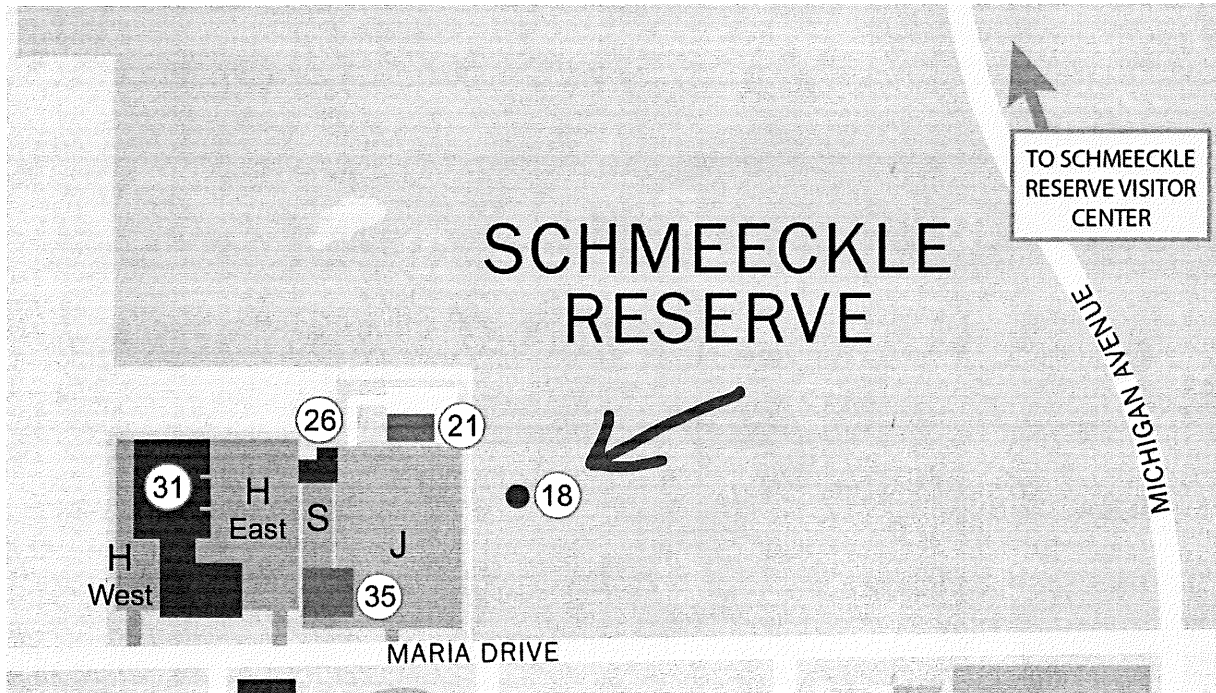


Figure 2. Map of Schmeeckle showing the meeting location at Schmeeckle pavilion, labeled number 18.

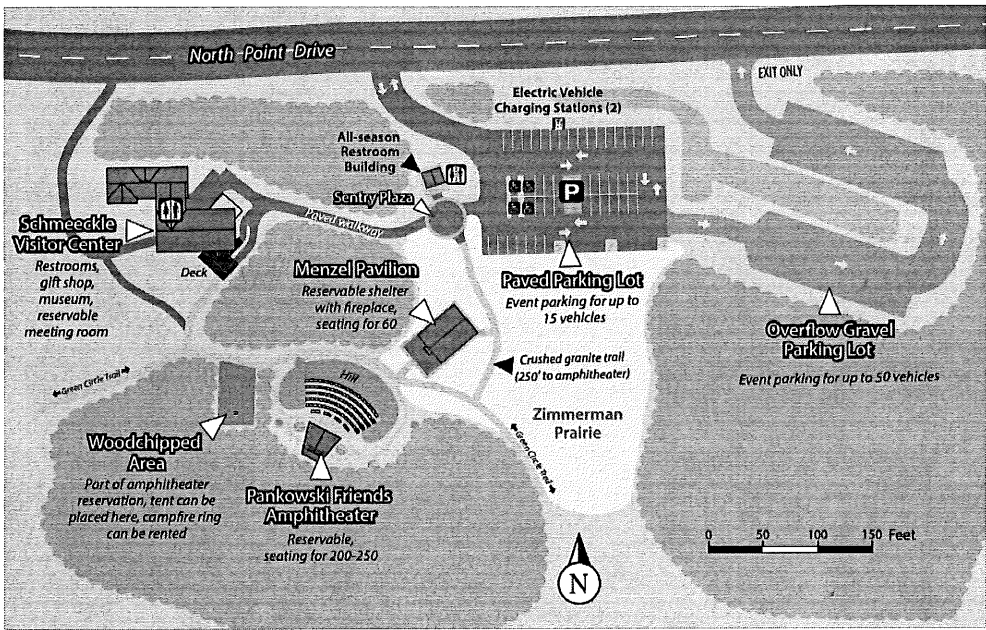


Figure 3. Map of Schmeeckle Visitor Center showing parking lot where we meet for Succession lab.
