#### **Course Description:**

The need for, purposes, making, and implementation of natural resources legislation and policy. Available for graduate credit as NRES 673.

## **Course Objectives:**

- 1. You will be able to demonstrate an understanding of key federal and Wisconsin natural resource laws.
- 2. You will be to describe and explain the various functions and constitutional foundations of federal, state, and local government in natural resource policy and law.
- 3. You will be able to explain and justify the need for policy in natural resource management, how policy is made and implemented and the stakeholders involved.
- 4. You will develop and demonstrate your critical thinking, problem solving, and oral and written communication skills to analyze natural resource problems and formulate policy solutions.

\*I will not adjust your grade up at the end of the semester just because you are "close" to the next grade. I do not give extra credit at the end of the semester. You must do the work during the semester to earn the grade you want and are capable of. I will round up from .5 to the next higher whole number.

**Quizzes:** There will be three quizzes, one at the end of each course module to assess your knowledge and understanding of that material.

**Final Exam:** The final exam will be cumulative and will assess your knowledge and understanding of the entire course and your problem solving, critical thinking, and writing skills.

**Presentation:** You and a classmate will give a five-minute oral presentation to the class on a natural resource policy and law issue, selected in consultation with the instructor. This assignment will develop and assess your oral presentation, critical thinking, and problemsolving skills. Further instructions will be provided in class. Depending on class size, some students may have to present solo.

**Peer Reviews:** You must complete three peer reviews of student presentations to develop your critical thinking, oral, and written communication skills. Peer reviews will be graded for quality by the instructor and then provided to the students that were reviewed.

**Assignments:** To develop and assess your critical thinking, problem solving, and writing skills, I will periodically assign in-class writing assignments, homework, and quizzes that you must complete satisfactorily in order to receive credit.

**Attendance:** Attendance in class is required. You are expected to fully participate in the course, e.g., attend lectures, participate in discussions, etc., and getting a good grade in the course is usually dependent on that. You will receive only two excused absences (see Due Dates/Late Policy); use them wisely. You are responsible for all missed material.

**Communication:** I expect students to check their UWSP email and the **Canvas** course site routinely for updates and materials.

Due Dates/Late Policy: All assignments are due on the specified due date at the beginning of class. Late assignments will incur a 10% penalty the first week they are late and a 20% penalty the second week they are late. Late assignments will not be accepted after two weeks. You are responsible for your own time management and keeping up with due dates. Serious medical or mental health emergency (self, parent, spouse, child), death of immediate family member (sibling, spouse, child, parent), military deployment, student-athlete sporting event, and natural disaster (e.g., tornado, flood, blizzard) may be cause for extending a due date if I am notified prior to the due date (email and voicemail have date and time stamps) and you can document (e.g., Dr.'s note) your absence.

**Course Effort/Study:** I believe being a full-time University student is akin to having a full-time job. A full-time job generally equates to at least 40 hours of work per week. You will only spend approximately a third of this time in class. You must spend the additional time on **your own** studying, reading, completing assignments, etc. To get the most out of this course and your University experience (i.e., grades, knowledge, skills, etc.), **you** must put in the time outside of class. A good rule of thumb is to plan on spending two hours of outside preparation for every hour you spend in class. Budget this time into your weekly/monthly planner.

# **Emergency Procedures:**

If you see/hear something, say something.

In the event of a medical emergency call 9-1-1 or use Red Emergency Phone. Offer assistance if trained and willing to do so. Guide emergency responders to victim.

In the event of a tornado warning, proceed to the lowest level interior room without window exposure. See <a href="https://www.uwsp.edu/rmgt/Pages/em/procedures/other/floor-plans.aspx">www.uwsp.edu/rmgt/Pages/em/procedures/other/floor-plans.aspx</a> for floor plans showing severe weather shelters on campus. Avoid wide-span structures (gyms, pools or large classrooms).

In the event of a fire alarm, evacuate the building in a calm manner. Meet at location 200 yards from building. Notify instructor or emergency command personnel of any missing individuals.

Active Shooter/Code React – Run/Escape, Hide, Fight. If trapped hide, lock doors, turn off lights, spread out and remain quiet. Call 9-1-1 when it is safe to do so. Follow instructions of emergency responders.
