This capstone course allows you to demonstrate proficiency in skills and knowledge gained in previous environmental education and interpretation courses, especially NRES 368 Oral Interpretation and NRES 369 Interpretive Media.

Policies and Expectations

- Schedule: The six-credit Schmeeckle practicum is a capstone course. It consists of several *independent* projects and programs.
 - The Monday Meetings are for project orientations, brainstorming, planning, scheduling, dress rehearsals, peer feedback, and group project planning sessions. We can add refresher sessions on media skills like Adobe Rush or InDesign or Photoshop upon student request. Plan to meet from 2:00-5:00 p.m.
 - o **Program Time:** Students lead two and assist with two other interpretive programs. You sign up for dates and times; typically, Fridays from 10-11, Saturdays from 7-8 or 10-11, or Sundays from 1-2. You may request an evening time.
 - o **Project Time:** Schedule ~12-15 hours each week to work on your program preparation and media projects.
 - o On-Site Preparation Time: A minimum of two hours on-site is required for most projects.
- Ambassadors of Schmeeckle: You are representatives of the Reserve. Please wear your staff shirts and dress appropriately for programs. Be a hospitable professional; see the <u>UWSP CNR Principles of Professionalism</u> for guidance.
- Attendance and Participation: We expect practicum students to attend and actively engage in all scheduled sessions.
- Late Work: Late work is automatically deducted -0.2% per hour late, or about -5% per day. Check that your files have been uploaded correctly in a readable file.
- **Preparation:** Be prepared for dress rehearsals. Failure to demonstrate acceptable preparation for dress rehearsals can result in cancellation of your dress rehearsal and associated project with no opportunity to make it up or earn those points.
- Exceptions to Policy: In general, you can plan ahead for scheduled events (concerts, vacations, athletic events). You should ask for exceptions for serious issues (funeral, accident, mono, covid, flu, etc.). Communicate ahead of time, and make sure to get the details recorded in writing (a.k.a. email) for any exceptions to policy.
