COURSE DESCRIPTION

This course is designed to provide you with an overview of the U.S. health system, its components, and the players that challenge the health policies. My goal is to present broad perspectives for understanding the U.S. health system within historical, social, political, and economic contexts that shape the health of Americans.

Broadly, we will discuss the five aspects of U.S. health politics and policies throughout the course. First, we begin by discussing the major characteristics and the beliefs and values underpinning U.S. health politics and policies. Second, we delve into the history of the system, describing the initial development and evolution of the system (*Foundations*). Next, we focus on the structure and process of the U.S. health care system, addressing the types of care and special populations for special care (Process). Third, we learn about each of the components of the system, including human resources and nonhuman resources such as finance and reimbursement (*Resources*). Fourth, we devote some time to discussing the issues and concerns about U.S. health politics and policies (*Outcomes*). We end the course by discussing the future of our health care system (*Outlook*).

LEARNING OUTCOMES

At the end of this course, you will:

- 1) Explain the components and workings of the U.S. health care system and the U.S. public health infrastructure
- 2) Understand the evolution of the U.S. health system and the influencing factors for the changes
- 3) Analyze the connections and interconnections between the components of the health care system

- 4) Identify the role of many players that have shaped the health politics
- 5) Scrutinize the complex socio-ecological issues that surround health and healthcare in America which create health disparities
- 6) Evaluate the existing health policies and recommend options for policy change.

GRADING SCALE



COURSE FORMAT

When you visit the course site, you will see **FIVE Modules**. For the 4-week semester, we will cover five modules. Module 1 is the introduction of the course, and you are invited to say "hello" to your classmates and to take the syllabus quiz. These activities ('Say Hello" Forum & a Syllabus Quiz) in Module 1 are also a part of graded assignments. For the remaining FOUR MODULES, we will cover the main subjects regarding the U.S. Health Politics and Policies. Each module is supposed to be completed within a week.

Although the official class period of POLI 306 starts on June 27 (Monday) and ends on July 22 (Friday), I extended a few more days to the course calendar to make **each week repeat the same format**. In this way, **you can easily follow the course**. That is, the last day of our class will be July 26 (Tuesday). Please see the course calendar for more information.



First, you will review learning materials by Thursday and take a module quiz by Friday. For a maximum outcome, you should read the chapter BEFORE you begin each module. After reading the chapter, please review learning materials such as PowerPoint slides with my voice lecture, videos, articles, data, and others. A module quiz is a learning tool to help you see how well you understand the course material. You will have **TWO** attempts to take a quiz. Please keep in mind that a different set of questions could be pulled from the exam bank for your second attempt. The highest score will be considered for your final grade.

Second, you need to complete the module activity by Saturday. The module activity could be the discussion forum where you are invited to express your opinion or a brief analysis of the given data or something else that is related to the topic of the module. Whatever the activity it is, clear instruction will be provided in the module. Reviewing the textbook chapter and learning materials is sufficient to complete a module activity.

Third, you will read and respond to TWO other students for the Module Activity by the following Tuesday. If you submit the module activity by its deadline, you will be automatically assigned to two students. You will read these students' posts and offer constructive and respectful feedback. Peer reviews are designed to foster active discussion among students, so completing peer reviews is a critical part of the required course work. Simple expressions and compliments such as "you did a good job!" and "I

agree with you." are not count for peer reviews. You should comment on the contents of your classmate's activity by sharing what you newly learn from it and whether you agree with your peer's analysis and arguments. ASSIGNMENTS

In addition to the weekly module activities, there are two assignment that must be submitted by its relevant deadline.

#1 Health Plan Evaluation Paper

Health plans vary in terms of what they cover, how much they cost, and a number of other factors. You are invited to evaluate your own health insurance plan according to the criteria provided by the instructor. It is worth **40 points** and should be submitted **by July 10 (Sunday)**. **This assignment requires that you have access to your health plan documentation.** Please locate this document as soon as possible. If it is impossible for you to access your health plan, please email me by 11:59 PM, July 2 (Saturday) so that I can assign you a randomly selected plan widely used in Wisconsin. But, try to find your own health insurance plan first. My sample plan should be the last solution. Please check the course site in Canvas for the complete paper guideline.

#2 The 7-Minute Video Presentation

Four main modules are organized by the broad framework, and each module covers a variety of topics within it. You are invited to present an informative briefing about what's happening in U.S. health politics and policies. Specifically speaking, you will read a few news articles featuring the topic(s) discussed in the module and analytically review the issue by applying learning materials. It is worth 60 points and should be submitted by July 24 (Sunday). Peer reviews will be a required component of this assignment too. This presentation will be delivered in a form of a video recording that your presence must be captured too. The detailed instruction will be provided on the course site under the title "Instruction about A 5-min. Presentation (Video-Recording)."

ONLINE ETIQUETTE

Because we do not meet in person, we may encounter a situation when our thoughts may not deliver in the way we intend. To prevent this problem in online communication, it is extremely important for all of us to follow the common netiquette rules below:

But, keep in mind that this forum is public. Don't post your questions if they contain any personal or confidential information. In this case, email me with your questions.
