Political Science 338: Environmental Law and Regulation

Catalog Description: In-depth coverage of federal environmental statutes and regulations including agency rules and court decisions. Areas of focus include air and water pollution as well as waste disposal. Both federal law and Wisconsin regulations will be covered where applicable.

Course Summary: Policy analysis is a skill that is useful in many fields and for understanding the debates that shape our society. This course will develop the practical skills involved in policy analysis: basic research, communications, and decision-making. We will also learn about different public policy issues along the way. Students will conclude the semester by putting their research, analysis, and communication skills into practice in a final guided project.

There are no formal requirements for the course. I do assume high-school level knowledge about the three branches of the federal government, separation of powers and 'checks and balances,' and how a bill becomes a law.

UWSP 14.01 Statement of principles
