- **LO 5:** Draw appropriate visual diagrams for business processes and data flow.
- **LO 6:** Evaluate internal controls in a business process with a focus on reducing risk.

Attendance at each event will count for 10 points towards your final grade.

You may earn Pro Events credits by attending both live Zoom events and in-person events.
