# I. Course Description & Learning Goals

## Description

This course prepares social work students to navigate the complex and challenging work involved in child welfare. Students will learn the history and current policies, statutes, and best practices that have and continue to shape child welfare in Wisconsin. Students will use the model of planned change to skillfully engage, assess, and intervene with families in child welfare. Students will complete currently utilized (eWISACWIS) templates to practice professional writing for social work meetings, multi-disciplinary meetings, and court reports.

# **Learning Goals**

It is the overall goal of the course to provide students the research and tools to assess, engage, and intervene effectively and ethically with people involved in the child welfare system. Additionally, students will: -Understand the history of child welfare in America.

- Identify and describe three (3) causes of child maltreatment.

- Design family-specific family interaction & safety plans using risk assessment outcomes and the strengths perspective.

- Identify the key Federal policies and Wisconsin State Statutes guiding child welfare and juvenile justice.

-Assess child-parent-foster parent dynamics to create appropriate visitation plans to manage dynamics and safety.

-Intervene with families using culturally appropriate, strengths-based, best practices (interventions) that encourage safety and improved family functioning.

# **III.** Course Content

#### **Class Format:**

The course format will include reading from a variety of sources, podcasts, videos, and written work. This class will also have a "laboratory" learning style. Students will work to assess and critically analyze presented information. Students will be required to apply existing knowledge, integrate new concepts and be challenged to critically think.

#### **Course Assignments:**

Students will be required to complete one discussion post, two reflection papers, four application and integration of learning papers, and a two-part research project. The specific requirements of each assignment are contained in Section V of this syllabus and posted in Canvas.

## V. Assignment Requirements & Details

## Mandated Report Training

Please go into the Canvas assignment module for Mandated Reporter Training. Access the link provided and successfully complete the Wisconsin Mandated Reporter Online Training. The training should take less than two hours. Once you complete the course, either take a photo of the "successfully completed" screen or wait for your certificate of completion to be emailed (may take up to two days). Upload either the photo or the certificate into Canvas. This is worth ten points.

#### **Reflection Paper: The Truth Podcast**

The purpose of the reflection paper is to further explore the issues being addressed in class, to develop reflective writing skills, and to allow opportunities for relating personal values and experiences to social work issues.

A reflection paper should capture <u>your assessment</u> of <u>your</u> current knowledge, beliefs, values, and attitudes concerning the assigned topic. The reflection paper <u>should not simply summarize</u> the information presented in the course but should challenge, further develop, or apply the information presented.

Listen to the Strangers Podcast episode, The Truth. The podcast release date was 10/28/2016. It is one of only a few free podcasts that are available to non-Patreon listeners.

This is an *extremely* difficult podcast to listen to. After you listen to the podcast, write a two to three-page reflection paper. Consider the following questions as you write your reflection paper:

1. What did you think and feel during the different parts of the story? What was hard to make sense of? Did your emotions change during the story? Did your assessment of the abuse change during the story?

2. How did this story impact your perspective on families involved in the child protective services system?

Reflection papers must be two to three pages (double spaced) in length with standard margins and 12 point font. Each reflection paper is worth 20 points.

# **Application and Integration Papers I, II, III,**

Students will then be provided an eWISACWIS template to complete. <u>The case study will NOT have all the information needed to complete all of content areas on the form.</u>

Read the case study, and then download and complete the eWISACWIS Initial Assessment template. If you feel you need additional information to thoroughly complete a narrative or scoring section of the template, at the close of your narrative include the additional questions you would ask of a case participant.

#### Paper III: Case Plan

Read the case study included in the Canvas assignment module. The case study is called, The Michelle and Joshua Case Study. Read the case study, and then download and complete the eWISACWIS Case Plan template. If you feel you need additional information to thoroughly complete a narrative or scoring section of the template, at the close of your narrative include the additional questions you would ask of a case participant.

#### Paper III: Court Report

Read the case study included in the Canvas assignment module. The case study is called, The Aaron and Amber Case Study. Read the case study, and then download and complete the eWISACWIS Court Report template. If you feel you need additional information to thoroughly complete a narrative or scoring section of the template, at the close of your narrative include the additional questions you would ask of a case participant.

# **Annotated Bibliography - Research Project**

This purpose of this assignment is to more deeply examine a specific client population of interest, to develop the research-informed practice skills, and to apply research to practice, including summarizing and presenting information to others. The annotated bibliography provides a significant amount of research for the Agency Presentation portion of the research project. PLEASE read the expectations for the Agency Presentation **prior** to selecting your population of interest, and beginning your research.

Identify a specific client population within child protective services to focus your research on. Examples of appropriate depth could include: child protective services and supporting infants with Failure to Thrive, child protective services and homelessness, child protective services with people who are not legal citizens, child protective services and substance use disorders. Please feel comfortable to email me with any questions regarding the scope of your project! It is better to work out the scope before digging into the research to learn the scope is too broad/too limited.

Identify information and resources relevant to the population as it relates to social work and child welfare practice and create an annotated bibliography in APA format. An annotated bibliography is a list of citations and each citation is then followed by a brief description that summarizes the identified resource. Annotations are typically five to seven sentences in length. The annotated bibliography will contain:

Title (client population)

<u>FIVE current articles from academic/professional/peer reviewed journals on social work practice with</u> your chosen client population. The articles must be published within the last seven years.

<u>ONE reputable and recognized</u> (nationally or state-wide) organization, agency, or department with data to identify the presence of your population of interest in our county, State, region or country.

The annotated bibliography is worth 100 points.

## Agency Presentation – Research Project

The second part of the research project is to develop a PowerPoint presentation to a real/imagined child welfare you would be working in. You may assume the audience you would present this PowerPoint to is an audience comprised of professional, licensed social workers and human service professionals in a thriving child welfare agency.

The PowerPoint presentation will educate your peers, supervisors, and management team on your specific population. The PowerPoint <u>will</u> contain:

A brief explanation how you understand child abuse/neglect occurs. Who is your population?\* How prevalent/common is the population in the area/state/region/country.\* What makes the population at risk for abuse/neglect or exclusion from detection?\* What are ways to assess, identify and/or build on their potential strengths?\* Are there barriers to thorough assessment? Are their barriers to serving the population?

\*<u>All</u> the answers to these questions should be taken from your annotated bibliography.

Using the textbook, supplemental readings and your additional research, identify <u>THREE</u> strategies to support this population of people.

Strategies include screening, assessments, evaluations, types of services offered, hiring personnel with specific types of education/training, training, ANYTHING we have discussed or you have researched that could positively impact engagement, assessment and intervention with people involved in the child welfare system.

Identify each strategy **and** explain why the specific strategy would be integral to support this population of people as they work with your agency.

Review the NASW Code of Ethics and cite TWO places in the Code which requires social workers to be able, trained, and knowledgeable to serve the population of people identified. Make a brief (two to three sentence) connection regarding <u>how the code requires</u> professional social workers to know and serve their client population <u>to your strategies</u> to better serve the population in your agency.

Your PowerPoint should have slides to cover each of the focus areas.

You will upload your PowerPoint and <u>you will NOT need to present or narrate it</u>. The PowerPoint will be graded solely based on the content of the PowerPoint.

The Agency Presentation is worth 200 points.
