Meeting Vignettes

Many Wisconsin communities provide public access to livestreamed meetings and recordings. Several communities with high quality audio and video recordings are highlighted below. Unique features of each setup are discussed, along with sample meetings to watch.

City of Stevens Point

The City of Stevens Point livestreams and records City Council, Plan Commission, Zoning Board, and other committee meetings. Links to each meeting are organized by committee and date on the city website. Recordings are made available through Granicus with videos synched and displayed on the same page as the agenda and meeting materials. Public hearings for conditional uses and rezones are conducted by the plan commission. Participants wishing to provide public input are asked to register in advance and approach the podium to speak. Discussion occurs after the public hearing is closed. Recommendations are forwarded to the city council and final decisions made at a separate meeting.



Staff Recommendation

Approve the conditional use permit to operate a non-owner-occupied tourist rooming house at 717 Ridge Road, subject to the following conditions:

- The establishment shall have a current license, as required by the Wisconsin Department of Health Services, Wisconsin Administrative Code Chapter 195.
- Owner shall register with Clerks and/or Treasurer's office and shall pay room tax as required under Sec. 4.13 of the Stevens Point Revised Municipal Code.
- 3) Maximum tourist occupancy shall comply with the minimum performance standards in the underlying zoning district regulations, parking regulations, and applicable building, fire, and occupancy codes, as amended. This shall require inspection by the Building Inspector or Zoning Administrator.
